Some **officiants** are church leaders who may or may not have formal training in crafting and delivering ceremonies. Additionally, the level of religious content in the ceremony often depends on their specific religious affiliation.

A **marriage commissioner** in British Columbia is a government-appointed official whose primary role is to legally solemnize marriages. Unlike celebrants, their focus is not on crafting personalized ceremonies but rather on ensuring the legal aspects of the marriage are fulfilled. Their scope of practice is generally more standardized and does not allow for the same level of customization or collaboration that a celebrant provides.
